Firm sees integrated software solutions as essential to doing business.

With 12 offices across Mississippi, **Watkins, Ward and Stafford, PLLC**, was starting to see inefficiencies working with a collection of standalone software programs. So after 23 years with another provider, the firm decided to switch to the CS Professional Suite from Thomson Reuters.

Watkins, Ward and Stafford's team can access the software and information they need from anywhere there's an Internet connection. That's a significant advantage to a firm with multiple locations.

"There's no more being out at a client's business and saying, 'Oh! I left that back at the office,'" Goodrum says. "Plus, these days you really need to be accessible and responsive whenever your clients need you."

Although staff members don't work remotely on a regular basis, being able to log in to respond to a client is a plus, she says.

"Work-life balance in accounting firms today is nothing like it was 20 years ago," Goodrum explains. "People don't have to be at the office until two or three o'clock in the morning anymore. We have to offer some flexibility to our employees, and technology helps us do that."

THE FULL PACKAGE

Watkins, Ward and Stafford has been adding modules to its suite of CS Professional Suite products over time. One of the first? CS Professional Suite Accounting (CSA).

"The accounting package is very stable," Goodrum says. "When I first started with the firm we did a lot of after-the-fact payroll and write-up, and we still do in some of our offices. CSA is a great program for payroll and processing and everything else."
