"Lacerte gave us no integration," Smith says, adding that it was a standalone tax package and thus, each of the firm's three locations was standalone. By moving to Virtual Office CS, an integrated product, the firm was able to integrate three offices virtually anywhere, which Smith could access via his laptop.

Another important benefit? Better work-life balance. Smith has four children and, outside of work, he spends most of his time with them. "UltraTax CS has made our work-life balance easier in our firm by allowing us to be more productive in the time that we are in the office," he says.
