## **PURPOSE**

This User Bulletin contains the IRS service center mailing addresses and related information.

## IRS service center reorganization

As part of the modernization initiative in the IRS Restructuring and Reform Act of 1998, some taxpayers will file at different IRS service centers for the 2008 (tax year 2007) filing season. UltraTax CS<sup>TM</sup> automatically prints the applicable IRS service center on the filing instructions and generates a For Your Information (FYI) diagnostic for any return being filed at a different service center for tax year 2007.

The following table lists the IRS service center changes in **bold** for individual taxpayers for tax year 2007.

*Note:* Returns for dual-status aliens, non-resident aliens, and state postal codes of "AS" (American Samoa), "MP" (Northern Mariana Islands), and "PR" (Puerto Rico) will file at Austin, TX.

*Important!* Tax preparers who use pre-printed mailing envelopes should review the IRS service center address on the envelope to ensure the taxpayer returns are sent to the correct IRS service center. Also, for 1040 returns, UltraTax CS uses the paid preparer (tax professionals) mailing addresses on the "Where to File Addresses for Tax Professionals for Use in Calendar Year 2008" page as published on the IRS website. In most cases, these paid preparer (tax professionals) addresses are different from the mailing addresses on the IRS pre-printed envelopes that the taxpayer receives with their tax package.

To use the IRS pre-printed envelopes from the tax packages and ensure the filing instructions match, mark the *Use taxpayer filing addresses* field in Screen Letter in the General folder. The

tax professional mailing addresses issued by the IRS will not be used. These addresses are available on the IRS website.

UltraTax CS automatically prints the applicable IRS service center mailing address on the payment vouchers for Forms 1040-ES, 1040-ES (NR), 1040-V, and 4868.
